POSITION- Counselor(Independent Contractor)

Provide leadership, encouragement, support and guidance. Hours are from 8:30 am to approximately 2:30 pm (Camp hours run from 9 am to 2 pm). Attend a mandatory organizational meeting a week or 2 before the start of camps. Counselors will be paid \$190/week as an independent contractor.

Job Prerequisites: Must enjoy working with kids. Must be enthusiastic, patient and exhibit a positive attitude. Minimum age is 15. **Counselors 15 years of age must have a work permit. Counselors, 16-17 years of age must have a Parental Permission Form** filled out along with a proof of birth date. **All Counselors will be required to have a BCII Background Check.** These forms will not be needed until you are hired.

Applicants willing and able to work multiple camps will be given greater consideration.
